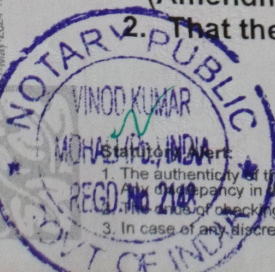

2. That the Shivalik Educational Society is of Non-Proprietary Character.

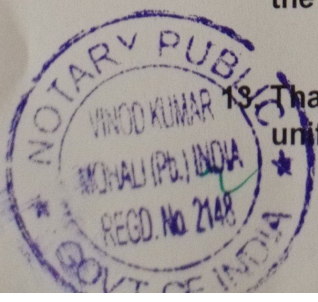

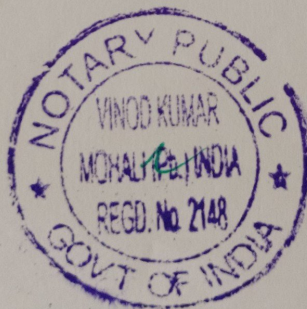
