Extension in provisional recognition is granted to Shivalik Public School. Sector 41-B, Chandigarh upto senior secondary level from 1.4.2018 to 31.3.2023 under Article 235 read with 241-A of Punjab Education Code subject to the condition that the school should ensure that all the conditions as given below are complied within six months before the expiry of the extended period of recognition failing which further recognition would not be considered:-

- Provisions of RTE Act and other instructions issued by the Education 1 Department related to admission of students under EWS category and disadvantages groups be followed in letter and spirit (wherever applicable);
- School will follow the provision of Rules of Recognition of Punjab Education 2 Code;
- School will follow land allotment conditions and other notifications/ orders/ 3 instructions issued by the Chandigarh Administration from time to time;
- Managing Committee will be got approved from the Department; 4.
- Salary to the staff be paid as per the CBSE Affiliation Bye Laws; 5.
- Reserve Fund be pledged as made applicable from time to time; 6.
- No particular book shop be prescribed for purchase of book/uniform etc. by 7. the school;
- Instructions/guidelines issued by CBSE relating to books/uniforms are to be 8 followed:
- Fire Safety norms be followed meticulously and there should be no laxity in 9. this regard on the part of school;
- Fee should be charged from the students as per CBSE Affiliation By Laws 10 and receipt be issued to the students against the money charged from them;
- Staff engaged should be fully qualified and untrained teachers should be 11. replaced with trained ones;
- Recognition is liable to withdrawn if the management or the staff of the school 12. take part in agitation directed against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political meetings or to engage in any form of political or communal agitation;
- Government reserves the right, to grant, refuse or withdraw recognition at its 13. entire discretion;
- School will recruit teachers as per NCTE notification dated 12.11.2014 14. regarding minimum qualification of teachers including the qualifications prescribed for teachers including the qualifications prescribed for teachers at pre primary level as per letter dated 2.4.2018;
- Latest Fire Safety Certificate should be obtaining from the Fire Department; 15.
- The management will not add any more class/section to the school without 16. the permission of the department.
- The school will send a quarterly report regarding the progress made towards 17. the fulfillment of various conditions mentioned above.
- The school will not be transferred to different building or locality not already 18 approved by the Department.
- The school will not be transferred to a different Managing Body already 19. approved by the Department.
