ORDER**

Provisional recognition is granted to Shivalik Public School, Sector 41 B, Chandigarh upto Senior Secondary Level for 4 years i.e. upto 31.03.2027 under Article 235 read with 241-A of Punjab Education Code subject to the condition that the school should ensure that all the conditions as given below are complied within six months before the expiry of the extended period of recognition failing which further recognition would not be considered:-

1. This provisional recognition is granted subject to the condition that documents/ information furnished by the Managing Committee is correct and not devoid of truth in any way. However, if any information at any stage is found contrary the provisional recognition would be revoked forthwith.
2. The Managing Committee and any changes to it should get prior approval from the Department.
3. The Managing Committee/School shall follow in letter and spirit the provisions of Punjab Education Code (as applicable to UT Chandigarh), the Right of Children to Free and Compulsory Education Act, 2009 and rules made there under (and as amended from time to time), the Punjab Regulation of fee of Un-aided Educational Institutions Act, 2016 (as applicable to UT Chandigarh) and any other applicable act/rule. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the Code/Act/Rules/Directions.
4. The Managing Committee will follow its land allotment conditions and other notifications/orders/instructions issued by the Chandigarh Administration/Department of Education, UT Chandigarh from time to time.
5. Salary be paid to the teachers and other staff strictly as per provision of Appendix-I of CBSE Affiliation by Laws/ norms which should be at par with the teachers working in Govt. School in U.T., Chandigarh.
6. The Managing Committee/School will recruit teachers as per NCTE notification dated 12.11.2014 (as amended from time to time) regarding minimum qualification.
7. The School shall follow the course of study as per syllabus prescribed by the affiliated board.
8. The Managing Committee/School will not add any class/section and/or shall not close down the school or and existing class during the academic session without the prior permission of the Chandigarh Administration/Department of Education, UT Chandigarh.
9. The Reserve Fund is to be pledged in the name of DEO, U.T., Chandigarh as per rule.
10. Instructions/guidelines issued by the Central Board of Secondary Education shall be followed.
11. The applicable Building and Fire Safety norms be followed meticulously and there should be no laxity in this regard.
12. Fee should be charged from the students as per CBSE Affiliation Bye Laws 2018 (as amended from time to time) and the Punjab Regulation of fee of Un-aided Educational Institutions Act, 2016 (as applicable to UT Chandigarh) as amended from time.
13. The School shall be open for inspection to the inspecting officer authorized by the Chandigarh Administration/Department of Education, UT Chandigarh.
14. Recognition is liable to be withdrawn if the management or the staff of the school take part in agitation against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political or communal agitation.
15. Chandigarh Administration/Department of Education, UT Chandigarh reserves the right, to grant, refuse or withdraw recognition at its entire discretion.

The recognition is also subject to the following conditions:-

1. Admission of 25% EWS students is to be made as per provisions of RTE Act, 2009 and 15 % admission beyond elementary classes as per land allotment obligatory of allotment letter (provisions of Capital of Punjab (Dev. & Reg.) Act, 1952).
2. NOC for Fire Safety may be obtained within a month's time period.
3. Salary to the staff is to be paid as per Govt. Norms.
4. EPF facility be provided as per Govt. Norms.
5. School busses have proper driver with valid license, fitness certificate of vehicles, fire extinguisher, speed control device, CCTV cameras and other requirements as per STA instructions.
6. School will follow the Building Bye Laws as notified by the Chandigarh Administration time to time.
