Sl. No.	The school is directed to ensure that:
1	The total number of sections for Bal Vatika is restricted to 06 (02 each for Bal Vatika I,II & III respectively). Further, the total number of sections for classes 1st to 10th shall be restricted to 12 only. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of 500 sq ft and greater in dimension.
2	The school has applied for secondary level and the Composite Science lab has not been developed with separate sections (Biology, chemistry & physics) with adequate seating arrangements as per Board guidelines. Further, the Lab has no safety measures like exhaust fans, Fire extinguishers, safety manual for users etc as per SoPs notified vide circular no 11/2022. School is directed to upgrade the lab with all recommended infrastructure and upload the compliance with video link within 03 months on SARAS portal.
3	School has not arranged the CwSN facilities properly as per Board guidelines vide circular no 05/2023. No ramp is seen at the school entrance and the toilets have been marked with sign 'handicapped' which is not as per norms. The school should have separate CwSN toilets for boys and girls at each floors with proper signage and upload the compliance within 03 months on SARAS portal.

4	As reported by the Inspection Committee, school should affix grills/safety mess in with video link within 03 months on SARAS portal.
5	School shall ensure the man la
	School shall ensure the mandatory training of its teachers from the CoE, CBSE Chandigarh and shall upload the compliance within 03 months on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
